Family & Children's Service Announces its 2021 Board of Directors

Long Branch, NJ (Jan. 26, 2021) – Family and Children's Service (FCS), Monmouth County's oldest, private nonprofit social service agency, has announced its board of directors for 2021-2022 and newly appointed Chairwoman, Tiffany Senft. Ms. Senft succeeds Deborah Zilai, who completed her three-year term in December 2020. She is the 34th person to serve as chair of FCS since the agency's founding in 1909.

It's truly my privilege to help address the needs of the community during the most challenging times of their lives."

Tiffany is a former co-owner and partner of Tonefarmer (2002-2017), a certified women-owned, nationally acclaimed commercial music production company in New York City. Ms. Senft resides in Fair Haven with her husband, Dr. Carl Senft, an ophthalmologist in Red Bank.
